- Credit for the course is awarded upon successful completion of the computer modules. **Students not complete by the end of summer school are not eligible to earn credit.**

## Dover High School Summer Credit Recovery Expectations

Summer school students will utilize an online learning application to recover credit toward graduation.

Students who have taken a class and not earned credit as the result of a failing grade or the Dover High School attendance policy are eligible to participate in the credit recovery program in order to recover the credit. Students from other schools will be admitted on a space available basis. Please note that a fee is associated with credit recovery courses held during summer school. To participate in the program the student must agree to and abide by the following expectations:

- Student computer use is monitored. Access is granted only for the purpose of completing Odysseyware or Educere assignments. Students are not allowed to access the internet while participating in credit recovery.
- The use of cell phones or other electronic devices are not permitted during classes. Music may be allowed at the discretion of the teacher.
- Students are expected to attend daily, arrive on time, and stay until dismissal until their course is complete.
- The student will work to complete the selected curriculum with due diligence during the scheduled program time. Mere attendance is not enough; students are to be actively engaged in their work while in the lab. Students will be provided with course information including progress goals. Students are expected to work consistently to meet these progress goals.
- Students who violate rules regarding computer use, use of electronic devices, the attendance policy or are not working consistently to meet goals will be warned and ultimately removed from the credit recovery program. **Refunds will not be granted.**
